## ADOPTION CONTRACT- Please read carefully

### As adopter I agree to the following:

1. Cats or kittens must be kept as indoor only pets.
2. To be fully responsible for all future medical care costs incurred after adoption. SCFS makes every effort to adopt out only healthy animals, but we cannot guarantee that health. If a pre-existing medical condition is missed by SCFS, the new owner has the option of returning the animal to SCFS for a refund or exchange of the animal within 7 days of adoption **or they must assume responsibility for the conditions at their own expense.** If the animal develops an illness immediately after adoption, **CALL US** prior to visiting your veterinarian. SCFS will not be responsible for any veterinary costs incurred if adopter fails to notify us first, and refunds will not be given.
3. SCFS will not be responsible for any medical treatment needed if the adopted pet transfers an illness to an existing animal owned by the adopter.
4. To adopt a pet, adopter must be 21 years of age or older.
5. SCFS has the right to refuse an adoption if it is not in the best interest of the animal.
6. I accept possession and title of this animal at my own risk, and hereby release and waive any right against **Second Chance For Strays, Inc.** for any damages to person or property caused by this animal in the future.
7. By signing this contract I agree to abide by all of its provisions and to permit **SCFS, Inc.** to investigate the premises where the animal is kept. If in their judgment the animal is not being properly cared for, **SCFS, Inc.** can reclaim the animal. Also if the adopter has not complied with any provisions of this contract or has misrepresented any facts, SCFS can reclaim any animal.

## REFUND/EXCHANGE POLICY

**SCFS Policy for full refund of Adoption Fee:** A full refund will be given if animal(s) are returned within 3 days of adoption for any reason. After 3 days, no cash refund will be given, but an exchange of cat/kitten will be possible if SCFS is agreeable. **IF FOR ANY REASON IN THE FUTURE YOU NO LONGER WANT OR CANNOT KEEP ONE OF OUR ADOPTED ANIMALS(S), PLEASE RETURN TO SCFS.** We are concerned for the welfare of all animals we rescue.
